Sub: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

Pursuant to Regulation 30 read with Schedule III of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI Listing Regulations”), this is to inform you that the Company has received a penalty order dated 20th February 2025 from the Deputy Commissioner of State Tax, Kolhapur, Maharashtra under Section 73(9) of Maharashtra Goods & Services Tax Act, 2017/ Central Goods & Services Tax Act, 2017 (“the Act”) and other applicable provisions in this regard. This pertains to FY 2020-21.

The details of the order as per SEBI Listing Regulations read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated 13th July 2023 are given below:

Impact on financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible	As per the Act, GST is not to be levied on steam which is used captively. However, assessing authority has taken different views. The Company is of the Bonafide view that it has good merit in the issue and therefore preferring an appeal before the Appellate Authority. There is no impact on the financial or operating activities of the Company.
