Further, the stakeholders are requested to note that the date of order, i.e. 4th September 2025, was inadvertently mentioned as the date of receipt of the order at point iii of our earlier intimation dated 18th September 2025. The actual date of receipt of the order by the Company was 17th September 2025 and accordingly the Company had filed an intimation with the stock exchanges within stipulated timeline of 24 hours i.e. 18th September 2025 and hence there was no delay in the filing of earlier intimation dated 18th September 2025.
