



**REPORT OF INDEPENDENT DIRECTORS' COMMITTEE OF SHREE RENUKA SUGARS LIMITED

SCHEME OF MERGER OF GOKAK SUGARS LIMITED WITH SHREE RENUKA SUGARS LIMITED**

In accordance with the requirements of SEBI Circular SEBI /HO/CFD/DIL1/CIR/P/2020/215 dated 3<sup>rd</sup> November 2020, the Board of Directors of Shree Renuka Sugars Limited (the Company), through circular resolution on 4<sup>th</sup> November 2020, constituted a Committee of the Independent Directors (the ID Committee) to review the scheme of proposed merger of Gokak Sugars Limited with the Company, or any modifications thereto, and give its recommendation to the Board of Directors.
